

A COMPARATIVE STUDY ON AWARENESS TOWARD GLOBAL WARMING AMONG LAW STUDENTS

ABSTRACT

This study is an attempt to identify the level of awareness toward global warming among law students. During the past few years, earth's climate has been noticed to be getting hotter and hotter, year after year which is caused mainly due to the deterioration of our environmental quality. Continuous industrialization, development of various transportation, and deforestation increase much SO_2 and CO_2 gases which augment global warming. The changes of global warming are visible from the highest mountains to deep in the oceans, and it extinguished different parts of the earth, and it also creates rich bio-diversity. The authors used purposive sampling, and 102 samples are collected only from the Law College, Neemuch area, which is located in Madhya Pradesh state, India. A self-made tool (global warming awareness study scale) made by investigators and was used for collecting the data from law students. The result shows that male and female, rural and urban law students are well aware of global warming, and they do not differ significantly toward global warming awareness.

This was followed by the framing of the core module syllabus for environmental studies for undergraduate courses of all branches of Higher Education. The success of this course will depend on the initiative and drive of the teachers and the receptive students. Hence, it is imperative to find out how far environmental law education has been effective in changing their mindset toward the environment. In response to this, the present survey was conducted with the aim of assessing the awareness of the law students. Thus, the present study was undertaken with the objective of assessing the awareness toward the issue of global warming awareness among law students. This study is an effort to find out the level of awareness of law students regarding global warming.

Objectives of the study

- To compare the awareness about global warming among male and female law students.

- To compare the awareness about global warming among rural and urban law students.

Hypothesis of the study

There is no significant difference between male and female law students about awareness of global warming.

There is no significant difference between rural and urban law students about awareness of global warming.

Sampling technique

The authors used purposive sampling, and 102 samples are collected only from the law college, Neemuch area, which is located in Madhya Pradesh state, India.

Tools

A self-made tool (global warming awareness study scale) made by investigators was used. It was 5 point scale and consists of 20 statements.

Data analysis

Table 1 shows that calculated value of t is less than the table value at 0.01 and 0.05 levels of significance. It shows that the awareness among male and female of law students do not differ significantly about global warming. So, our first hypothesis is accepted that there is no significant
